## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“Release”) is made and effective as of September 28, 2018 and is granted by CIBC Bank USA, a Illinois state banking institution (formerly known as The PrivateBank and Trust Company) (“Lender”), in favor of Trystar, Inc. (formerly known as Bridgewater Tech, Inc.), a Minnesota corporation (“Debtor”).

Lender hereby releases and terminates, without recourse, representation or warranty, any and all of its security interest that it has pursuant to the Trademark Security Agreement in any and all right, title and interest of the Debtor and reassigns to the Debtor any and all right, title and interest that Lender may have in and to Debtor’s (i) trademarks, service marks, collective membership marks, registrations, applications for registrations, and the respective goodwill associated with each, (ii) licenses, fees, or royalties with respect to each mark, (iii) the right to sue for past, present, and future infringement, dilution, and damages therefore, and (iv) licenses thereunder all as presently existing or hereinafter arising or acquired, including, without limitation, the marks and registrations identified in the attached Exhibit A (hereinafter “the Trademarks”).

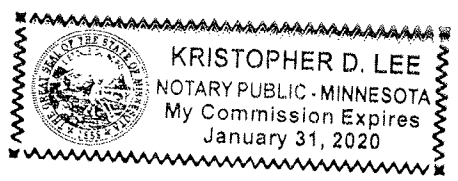
