## CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "IP Assignment Agreement"), is effective as of August 31, 2018 ("Closing Date"), by and among Cooke Communications Florida, L.L.C., a Delaware limited liability company ("CC-FL"), Cooke Communications North Carolina, a Delaware limited liability company ("CC-NC", individually or together with CC-FL, as the context requires, "Assignors"), and APG/East, LLC, a Delaware limited liability company ("Assignee"). Capitalized terms used but not otherwise defined herein shall have the respective meanings set forth in that certain Asset Purchase Agreement entered into between, *inter alia*, the Assignors and the Assignee of even date herewith ("Purchase Agreement").

### RECITALS

WHEREAS, pursuant to Section 2.1 of the Purchase Agreement, Assignors have agreed to sell, assign, convey, transfer and deliver to Assignee, and Assignee has agreed to purchase and acquire from Assignors, all of Assignors' right, title and interest in, to and under the Purchased Assets, including the Purchased IP (as that term is defined in the Purchase Agreement); and

WHEREAS, pursuant to Section 7.1(i) of the Purchase Agreement, Assignors and Assignee have agreed to enter into this IP Assignment Agreement to evidence the transfer of such Purchased IP from Assignors to Assignee;

WHEREAS, Assignors executed that certain Intellectual Property Assignment Agreement, dated August 31, 2018, between Assignors and Assignee ("Assignment") assigning to Assignee all right, title and interests to the Purchased IP;

WHEREAS, the parties desire to confirm the rights assigned to Assignee under the Assignment.

NOW THEREFORE, in consideration of the foregoing and the representations, warranties and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

**Section 1 Assignment of Intellectual Property.** The parties confirm that, effective as of August 31, 2018, Assignors did sell, assign, convey, transfer and deliver to Assignee, and Assignee did purchase, acquire, accept and assume from Assignors, and to the extent any of Assignors' rights were not sold, assigned, conveyed, transferred and delivered to Assignee, Assignors do hereby sell, assign, convey, transfer and deliver to Assignee, and Assignee does hereby purchase, acquire, accept and assume from Assignors, effective as of August 31, 2018, all of Assignors' worldwide rights, title and interest in and to the Purchased IP and all intellectual property rights contained in the foregoing, including, without limitation as set forth on Schedule A attached hereto, and including without limitation (a) rights under which an inventor, author or other person is obligated to assign ownership any of the foregoing; (b) all registrations and applications for the foregoing; and all common law rights in the foregoing; (c) all rights to request, apply for, file and register the foregoing; (d) all defenses relating to or arising from all rights of action arising from the foregoing, including without limitation all claims for damages by reason of present, past and future infringement, misappropriation, violation, misuse, breach or default of the foregoing and all present, past and future rights to sue and collect damages or seek injunctive relief for any such infringement, misappropriation, violation, misuse, breach and default of the foregoing; (e) all goodwill of the business connected with the use of, and symbolized by, the Purchased IP; and (f) all income, royalties and any other payments now and hereafter due and/or payable to Assignors in respect of the foregoing (all of the foregoing, collectively, the "Assigned IP"), to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held as fully and entirely by Assignors had this assignment not been made.

**Section 2 Further Assurances.**

a. Assignors hereby covenant and agree that they shall, at any time after the Closing Date or from time to time thereafter at the reasonable request of Assignee and at Assignee's expense, (a) execute and deliver such further instruments of sale, assignment, conveyance, transfer and delivery to Assignee as shall be reasonably necessary or appropriate to effectively consummate the assignments contemplated hereby, and (b) reasonably assist Assignee, at Assignee's request, in exercising Assignors' rights with respect thereto.

b. Assignors authorize and request the Commissioner of Patents and Trademarks of the United States of America, the United States Copyright Office, and all applicable officials of any other state or foreign agencies or authorities, governmental or otherwise, to issue or transfer all of the Assigned IP to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.

c. As and to the extent that any governmental or quasi-governmental office or agency pertaining to the filing, registration, application or processing of intellectual property, including without limitation the United States Patent and Trademark Office, the United States Copyright Office, and other state or foreign offices in which any of the Assigned IP listed in Schedule A is or was registered, applied for, pending or recorded, requests that additional forms or documents be presented or executed by Assignors or their agents, affiliates or attorneys, Assignors shall execute such documents and deliver them to Assignee or Assignee's agents, attorneys or designees, as applicable pursuant to Section 2.a above.

d. Assignors agree to carry out, or have carried out for them, the formal transfer of the Domain Names to Assignee in accordance with the domain name transfer procedures of the Domain Name registrar or other current procedures as required to transfer ownership, registration and all other right, title and interest in the Domain Names to Assignee, including the delivery of the proper transfer codes to authorize the transfer of the Domain Names. Assignors agree that until the account change is completed, Assignors will maintain the websites located at the Domain Names in a manner consistent with past practices.

**Section 3 Successors and Assigns.** The terms and provisions of this IP Assignment Agreement shall be binding upon, and inure to the benefit of, Assignors and Assignee, and each of their respective successors and assigns.

**Section 4 Third Party Beneficiaries.** Nothing in this IP Assignment Agreement is intended to or shall confer upon any Person other than the parties and their respective successors and assigns, any rights, benefits, or remedies of any nature whatsoever under or by reason of this IP Assignment Agreement or any transaction contemplated by this IP Assignment Agreement.

**Section 5 Choice of Law.** This IP Assignment Agreement and the rights and obligations of the parties shall be governed by and shall be enforced and interpreted in accordance with the laws of the Commonwealth of Virginia, without regard to conflicts of law doctrines.

**Section 6 Counterparts.** This IP Assignment Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Copies (facsimile, electronic or original) of signatures to this IP Assignment Agreement shall be deemed to be originals and shall be binding to the same extent as original signatures.




