DECLARATION

1. I, Martin Berry, am the Vice President of Finance and Secretary of Keeco, LLC, a California limited liability company ("KEECO"), and I am authorized to make this Declaration on KEECO's behalf.
2. Aeolus Down, Inc., a California corporation ("AEOLUS") is the current owner and registrant of the trademark registrations identified in the attached Exhibit A (the "Trademarks").
3. KEECO acquired, by a Stock Purchase Agreement dated September 27, 2013, all outstanding shares of AEOLUS.
4. On March 13, 2014, KEECO as sole shareholder, filed a Certificate of Dissolution of AEOLUS Down, Inc. (see attached Exhibit B), dissolving AEOLUS.
5. As sole shareholder of AEOLUS, KEECO acquired all of the assets of AEOLUS including the Trademarks through the dissolution of AEOLUS.
6. KEECO is the current owner of the Trademarks, and the USPTO records should be updated to reflect the same.
7. All statements made herein of my own knowledge are true and all statements made on information and belief are believed to be true; and further, these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of this document.



ARTICLE V


The election to dissolve was made by the vote of all the outstanding shares.
