## TERMINATION OF SECURITY INTEREST

WHEREAS, Mountain Valley Spring Company, LLC, an Arkansas limited liability corporation (the "**Grantor**"), was the owner of record of the trademarks and applications listed on Schedule I hereto (the "**Trademarks**");

WHEREAS, Grantor entered the Trademark Security Agreement dated March 28, 2006 (the "**Security Agreement**") between Grantor and JPMorgan Chase Bank, N.A. (the "**Grantee**"), a true and correct copy of which was recorded by the United States Patent and Trademark Office on November 27, 2006, at Reel 3434/Frame 0018

WHEREAS, pursuant to the Security Agreement Grantor granted a security interest to Grantee in the Trademarks;

WHEREAS, all obligations secured by the Security Agreement were satisfied and the Security Agreement was terminated on February 21, 2014;

WHEREAS, the Grantee desires to release its security interests in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is acknowledged, Grantee:

1. Hereby releases, without recourse or representation or warranty, express or implied, any and all liens, security interests, right, title, and interest of Grantee pursuant to the Security Agreement in and to the Trademark Collateral, including, without limitation, all of the following:

(a) all trademarks (including service marks), trade names, trade dress, and trade styles and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing, including, without limitation, each trademark listed on Schedule 1 attached hereto (and all amendments, supplements, restatements and modifications thereof or thereto from time to time), and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark;

(b) all licenses or similar arrangements of any of the foregoing, whether as licensee or licensor;

(c) all renewals of any of the foregoing;

(d) all income, royalties, damages, claims and payments now or hereafter due or payable with respect of any of the foregoing, including, without limitation, damages, claims, and payments for past and future infringements thereof;

(e) all rights to sue for past, present, and future infringements of any of the foregoing, including the right to settle suits involving claims and demands for royalties owing;

(f) all rights corresponding to any of the foregoing throughout the world; and

(g) all products and proceeds of any of the foregoing.

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.

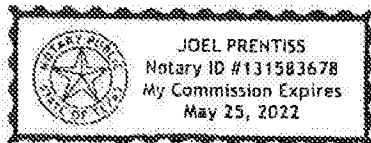
