**TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Trademark Release”) is made as of October 26, 2018, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a Swiss bank, as Collateral Agent (the “Collateral Agent”) in favor PARADIGM MANAGEMENT SERVICES, LLC, a Delaware limited liability company with an address at 1277 Treat Boulevard, Suite 800, Walnut Creek, California 94597 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated October 12, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on October 12, 2017 at the United States Patent and Trademark Office at Reel 006181, Frame 0483.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its Trademark Collateral, including without limitation the Owned Trademarks listed in Schedule A, and all of the goodwill associated with such Trademark Collateral.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders and other holders of the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including the goodwill associated with such Trademark Collateral, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
