NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

WHEREAS, by an Intellectual Property Security Agreement dated as of November 29, 2017, recorded with the United States Patent and Trademark Office on December 11, 2017 at Reel 6225, Frame 0075, Welcome Commerce, Inc. NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Assignee hereby relinquishes, releases and discharges its security interest in the Trademark Collateral.
