RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** (the "Release"), is dated as of October 29, 2018, by **BANK OF AMERICA, N.A.**, as administrative agent (together with its successor(s) thereto in such capacity) (the "Agent"), in favor of **ELIASSEN GROUP, LLC**, a Delaware limited liability company (the "Grantor").

W I T N E S S E T H

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 27, 2014 made by Grantor in favor of Agent (the "Security Agreement"), a security interest in and continuing lien on all of such Grantor's right, title and interest in, to and under the Trademarks of such Grantor, including those identified on Schedule A attached hereto (the "Trademark Security Interest");

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on August 29, 2014 at Reel/Frame 5354/0473;

WHEREAS, Grantor has satisfied in full the terms of the Security Agreement and requests a release of the Trademark Security Interest; and

WHEREAS, Agent, on behalf of itself and the Secured Party, desires to terminate and grant a release of the Trademark Security Interest as provided in this Release.

NOW, THEREFORE, for good and valuable consideration tendered by the Grantor, the receipt and adequacy of which are hereby acknowledged, the Agent, on behalf of itself and the Secured Party, does hereby agree as follows:

1. The Agent, on behalf of itself and the Secured Party, hereby (a) terminates the Security Agreement, (b) releases, relinquishes, terminates and discharges the Trademark Security Interest in its entirety and (c) reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the any of the Trademark Collateral (including, without limitation, the Trademarks identified on Schedule A attached hereto) and associated common law rights and goodwill appurtenant thereto.

2. The Agent, on behalf of itself and the Secured Party, authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release.

3. At the request and sole expense of the Grantor, the Agent, on behalf of itself and the Secured Party, agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release


