TERMINATION AND RELEASE OF  
GRANT OF TRADEMARK SECURITY INTEREST (FIRST LIEN)

This TERMINATION AND RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST (FIRST LIEN) ("Termination and Release") dated as of October 29, 2018, is made from WELLS FARGO BANK, N.A., as agent (in such capacity, the "Agent") to RM Chevys LLC, a Delaware limited liability company, RM Acapulco LLC, a Delaware limited liability company, RM El Torito LLC, a Delaware limited liability company, and RM Foods LLC, a Delaware limited liability company (each, a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to that certain Pledge and Security Agreement (First Lien) dated as of March 21, 2012, by and among the Agent and the Grantors (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), the Grantors and the Agent entered into that certain Assignment for Security - Trademarks, dated March 21, 2012 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office on March 21, 2012 at Reel 4740, Frame 0530, pursuant to which the Grantors granted a continuing security interest to the Agent, for the benefit of the Agent, the Lenders and Noteholders, in the Collateral, including the Trademarks listed on Schedule A hereto and made a part hereof (collectively, the "Trademark Collateral"); and

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title and interest in the same to Grantor.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Agent hereby terminates and releases its security interest in all of Grantors' right, title and interest in and to the Trademark Collateral.
3. Agent hereby assigns, grants and conveys to the Grantors, without any representation, warranty, recourse or undertaking by the Agent, Agent's security interest in the Trademark Collateral.
4. Agent hereby authorizes and requests the Commissioner for Trademarks at the United States Patent and Trademark Office or his or her delegate to record this Termination and Release against the Trademark Collateral.
