RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of August 3, 2018, by CITY NATIONAL BANK, a national banking association ("Bank") in favor of KYRIBA CORP., a Delaware corporation ("Grantor") with its principal place of business located at 9620 Towne Centre Dr., Suite 250, San Diego, CA 92121.

Recital

WHEREAS Grantor granted to Bank a security interest in Grantor's right, title and interest to the trademarks described on Exhibit A attached hereto (the "Intellectual Property Collateral") under that certain Intellectual Property Security Agreement dated as of May 6, 2016 (as amended from time to time or otherwise in effect prior to the date hereof, the "Security Agreement"), recorded with the US Patent and Trademark Office ("USPTO") on May 9, 2016 at Reel/Frame 5789/0217.

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to terminate the Security Agreement and release its security interest in the Intellectual Property Collateral.

Agreement

Now therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby terminates the Security Agreement and terminates and releases its security interest in the Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral. Bank authorizes Grantor and its designees and agents to record this Release with the USPTO and other applicable registries at the sole expense of Grantor and agrees to provide Grantor with any information and additional authorization necessary to effect the release of the security interest in the Intellectual Property Collateral.
