## TRADEMARK ASSIGNMENT

WHEREAS, Assignor desires to assign all of its right, title and interest in and to the Trademark to Assignee and Assignee desires to accept such assignment and to assume all liabilities and obligations of Assignor associated with the Trademark.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns and transfers unto Assignee, its successors, heirs and assigns all right, title and interest in and to the Trademark, including without limitation, the right to any registrations thereof, the right to prosecute any applications therefor, the right to have any registrations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to any priorities based on the filing of the aforesaid application, the right to sue for past and future infringement, and the right to the goodwill of the business symbolized thereby.
2. Binding Provisions. This Assignment is binding upon, and inures to the benefit of the parties hereto and their respective heirs, executors, legal representatives, successors, and assigns.
3. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to any conflicts of law provisions of such state.
4. Counterparts. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile or other means of electronic transmission (i.e., pdf) shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
