TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("**Trademark Assignment**"), dated as of September 4, 2018, is by and between GEMINI CORPORATION, a Michigan corporation (collectively, the "**Seller**") and GEMINI MEDIA, LLC, a Michigan limited liability company ("**Buyer**"), the purchaser of certain assets of Seller pursuant to an Asset Purchase Agreement between Buyer and Seller, dated as of September 4, 2018 (the "**Asset Purchase Agreement**"), the terms of which are incorporated herein by this reference.

WHEREAS, under the terms of the Asset Purchase Agreement, Seller has conveyed, transferred, and assigned to Buyer, among other assets, certain intellectual property of Seller, and has agreed to execute and deliver this Trademark Assignment.

NOW, THEREFORE, the parties agree as follows:

1. **Trademark Assignment.** For the consideration set forth in the Asset Purchase Agreement, the receipt and adequacy of which is hereby acknowledged, Seller hereby irrevocably sells, assigns, transfers, and conveys to Buyer all of Seller's right, title, and interest in and to the trademarks, trade names and service marks set forth on Schedule 1.1(a) to the Asset Purchase Agreement (collectively, the "**Trademarks**"); including the current registration thereof with the registrar(s) separately provided by Seller to Buyer.

2. **Transfer of Trademark.** The parties will follow the registrar's standard process to effectuate the transfer of ownership and control of the Trademarks to Buyer as soon as practicable following the date hereof.

3. **Miscellaneous.**

(a) This Trademark Assignment shall be governed by and construed in accordance with the internal laws of the State of Michigan without giving effect to any choice or conflict of law provision or rule (whether of the State of Michigan or any other jurisdiction).

(b) This Trademark Assignment shall be binding upon and shall inure to the benefit of Seller and Buyer and their respective successors and assigns.

(c) This Trademark Assignment may be executed in multiple counterparts and by facsimile signature, each of which shall be deemed an original and all of which together shall constitute one instrument. A signed copy of this Agreement delivered by facsimile, email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

(d) This Trademark Assignment is made pursuant to the Asset Purchase Agreement and is subject to its terms. In the event of a conflict between the terms of

the Trademark Assignment and the Asset Purchase Agreement, the terms and conditions of the Asset Purchase Agreement shall control.




