
The undersigned, Gary Van Gundy, Chief Executive Officer of DRT Holdings, Inc., requests that title records concerning the above-identified registration be amended to show that Aeromed, Inc., a New York corporation with its principal place of business at 26 East Main Street Amsterdam, New York 12010, is the owner of Reg. No. 3161965.

According to the records of the United States Trademark Office, Reg. No. 3161965 issued to Aeromed, Inc. on October 24, 2006. A document entitled NUNC PRO TUNC ASSIGNMENT OF TRADEMARK was recorded against Reg. No. 3161965 at Reel 006162 Frames 0936 and 0937 of the Trademark Office Assignment Records. The document purported to transfer Reg. No. 3161965 from Aeromed, Inc. to DRT Medical, LLC, an Ohio limited liability company corporation with its principal place of business at 618 Greenmount Blvd., Dayton, Ohio 45419.

In fact, the recitation that Aeromed, Inc. assigned Reg. No. 3161965 to DRT Medical, LLC was erroneous. The nunc pro tunc assignment document was prepared and recorded to reflect a merger between DRT Medical, LLC and another company owned by DRT Holdings, Inc. The parties believed that the other company owned by DRT Holdings, Inc. owned Reg. No. 3161965 when it did not. I signed the nunc pro tunc assignment document in error.

To my knowledge, ownership of Reg. No. 3161965 has never changed. To my knowledge, the last correct owner of Reg. No. 3161965 has been and continues to be Aeromed, Inc.


WHEREAS, Parent owns all of the outstanding membership interests in and to DRT Medical, LLC ("Assignee");


WHEREAS, Assignor and Assignee are desirous of making this Assignment of the Mark a matter of record.
