**TRADEMARK ASSIGNMENT**

**WHEREAS**, Assignor has filed Articles of Dissolution and, pursuant to the Plan of Complete Liquidation and Dissolution of Assignor, would like to confirm, in writing, the assignment of the Trademark to Perficient, as sole shareholder of Assignor; and

**WHEREAS**, Perficient is desirous of confirming, in writing, the acquisition of all of Assignor's right, title and interest in and to the Trademark.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:



Assignor hereby sells, transfers and assigns to Perficient all right, title and interest Assignor has in and to the Trademark, together with (i) the goodwill of the business symbolized by said Trademark, (ii) all registration(s) and application(s) for the Trademark, including U.S. trademark registration number 4337723 for the ELIXITER logo, and (iii) any and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for infringement of the Trademark.

2. Assignor hereby consents to the recordation of this assignment in any applicable jurisdiction and before appropriate trademark offices. Assignor will assist Perficient and execute additional documents and instruments as may be reasonably necessary to secure, perfect, maintain, confirm or evidence the rights hereby transferred.

3. The parties agree that this Assignment may be executed using electronic signatures, including scanned copies of signatures in PDF format, and such electronic signature pages shall in all respects be binding on all parties hereto as if such signature pages were originally delivered. This Assignment may be executed in multiple counterparts, but all of which together shall constitute one and the same instrument.

IN WITNESS WHEREOF, the authorized representatives of the parties hereto duly execute this Assignment.


