RELEASE OF SECURITY INTEREST IN TRADEMARK REGISTRATION

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of October 19, 2018 ("Effective Date") by and between LOANLOGICS, INC., a Delaware corporation, with its office at 100 Valley Road, Suite 201, Mt. Arlington NJ 07856, ("Grantor") and PACIFIC WESTERN BANK, a California State Chartered Bank (AS SUCCESSOR IN INTEREST BY MERGER TO SQUARE 1 BANK), with its office at 406 Blackwell Street, Suite 240, Durham NC 27701, in its capacity as collateral agent on behalf and for the benefit of the Secured parties ("Grantee").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Grantee dated 29th May 2013 (the "IP Security Agreement"), the Grantor granted to Grantee a continuing security interest in and to all of such Grantor's right, title and interest in and to all of the Trademarks, and registrations of and applications to register the foregoing, (collectively, the "Trademark Collateral"), including, without limitation, the United States Trademark registration set forth on Schedule A attached hereto, together with the goodwill associated therewith (the "Scheduled Trademark");

WHEREAS, Grantor and Grantee entered into the IP Security Agreement pursuant to the terms and conditions of that certain Loan Agreement by and between Grantors and Grantee dated 22nd December 2010 (the "Security Agreement");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on 07/16/2014 at Reel 5323 Frame 0509; and

WHEREAS, Grantor requests a release to the Scheduled Trademark, and Grantee desires to release its security interest in and to the Scheduled Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby acknowledges that the IP Security Agreement has automatically terminated pursuant to its terms with respect to the Scheduled Trademark and releases any and all security interests, liens and any other right that may have been granted to Grantee in and to the Scheduled Trademark.

Grantee shall take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by such Grantor to more fully and effectively effectuate the purposes of this Release. Grantee authorizes and requests that the PTO note and record the existence of this Release.
