Release of Security Interest in Trademarks

This **Release of Security Interest in Trademarks**, dated as of October 31, 2018 (this “**Release**”), is made by Morgan Stanley Senior Funding, Inc., as collateral agent (in such capacity, the “**Collateral Agent**”) in favor of Marketo, Inc., a Delaware corporation and Bizible, Inc., a Washington corporation (each a “**Pledgor**” and, collectively, the “**Pledgors**”).


WHEREAS, by (i) that certain Security Agreement dated as of February 7, 2018 by and among the Collateral Agent and the Pledgors party thereto (as amended by that certain Joinder Agreement dated as of July 2, 2018, and otherwise amended, restated, or modified from time to time, the “**Security Agreement**”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement), (ii) the related Trademark Security Agreement dated as of February 7, 2018 by and among the Pledgors party thereto and the Collateral Agent, which was recorded with the United States Patent and Trademark Office on February 9, 2018 on Reel 6268 Frame 0093 and (iii) the related Trademark Security Agreement dated as of July 2, 2018 by and among the Pledgors party thereto and the Collateral Agent, which was recorded with the United States Patent and Trademark Office on July 3, 2018 on Reel 6371 Frame 0015 (the agreements referenced in clauses (ii) and (iii), each a “**Trademark Security Agreement**” and, collectively, the “**Trademark Security Agreements**”), each Pledgor, pledged and assigned to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set-off against, any and all right, title and interest of such Pledgor in and to all Trademarks, including the trademarks set forth on Schedule I hereto;

WHEREAS, each Pledgor desires the Collateral Agent to release its continuing security interest in, and right to set-off against, any and all right, title and interest of each Pledgor in and to all Trademarks, including the trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, does hereby release its continuing security interest in, and right to set-off against, any and all right, title and interest of each Pledgor in, to, and under all Trademarks, including, without limitation, the United States registered Trademarks and applications for Trademark registration, set forth on Schedule I hereto, granted pursuant to the Security Agreement or the Trademark Security Agreements, and all goodwill and Proceeds of any and all of the foregoing.
