TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into on October 31, 2018 (the "Effective Date"), by and between New West Environmental, LLC, an Arizona limited liability company (the "Assignor") and New West Oil Company, L.L.C., an Arizona limited liability company ("Assignee").

WITNESSETH

NOW, THEREFORE, for valuable consideration, the receipt of which is acknowledged, the parties hereto agree as follows:

The Assignor does hereby, sell, assign, transfer and set over to Assignee all of its right, title and interest in and to the Trademark in the United States and all jurisdictions outside the United States including, without limitation, the ongoing and existing portion of the Assignor's business associated with the Trademark, together with the goodwill of the business connected with and symbolized by the Trademark (including, without limitation, the right to sue and recover for any past or continuing infringements or contract breaches related to the Trademark, the right to renew any registrations including in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise from the Trademark), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.



Assignor further agrees to, upon the request and at the expense of Assignee, (a) cooperate with Assignee in the protection of the trademark rights and prosecution and protection of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including registration applications and instruments of transfer; and (c) perform such other acts as Assignee lawfully may request in order to obtain or maintain the Trademark and any and all applications and registrations for the Trademark.


