RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, reference is made to that certain Notice of Grant of Security Interest in Patents dated October 3, 2016, which was recorded in the United States Patent and Trademark Office on October 18, 2016, at Reel 040048 Frame 0642; Notice of Grant of Security Interest in Trademarks dated October 3, 2016, which was recorded in the United States Patent and Trademark Office on October 18, 2016, at Reel 5902 Frame 0105; and Notice of Grant of Security Interest in Copyrights dated October 3, 2016, which was recorded in the United States Copyright Office on October 11, 2016, at Volume 9943 Document No. 683 (collectively, as amended, restated, supplemented or otherwise modified from time to time, the “*IP Security Agreements*”), by and between WALKER EDISON FURNITURE COMPANY LLC, a Utah Limited Liability Company (the “*Grantor*”), and Agent; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the IP Security Agreements; and

WHEREAS, under the IP Security Agreements, Grantor granted Agent a continuing security interest in all of the right, title and interest of Grantor in and to the intellectual property collateral identified therein (the “*Intellectual Property Collateral*”), including certain intellectual property described in Schedules A, B, and C attached hereto, and the Agent now desires to terminate and release its security interest in the Intellectual Property Collateral and reassign any and all rights, title, and interest in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby irrevocably and forever releases and terminates its security interest in and to the Intellectual Property Collateral, including, without limitation, the intellectual property described in Schedules A, B, and C attached hereto.
2. If and to the extent that the Agent has acquired any right, title or interest in or to any of the Intellectual Property Collateral, the Agent hereby reassigns, grants and conveys to the Grantor any and all of its right, title, and interest in and to the Intellectual Property Collateral (including, without limitation, the intellectual property described in Schedules A, B, and C attached hereto), along with any goodwill in the Intellectual Property Collateral that the Agent may have acquired.
