TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Agreement”) dated as of January 26, 2018, from BANK OF AMERICA, N.A., a national banking association, in its capacity as agent (“Agent”), to ALEXIN, LLC (the “Company”).

WITNESSETH:

WHEREAS, pursuant to (i) that certain Trademark Security Agreement dated as of November 30, 2011, executed by the Company in favor of the Agent, and (ii) that certain Loan and Security Agreement dated as of November 30, 2011, executed by and among the Company, the Agent, and certain other financial institutions party thereto (collectively, the “Security Agreement”), a security interest (the “Security Interest”) was granted by the Company to the Agent in certain trademark registrations and trademark applications, including the trademark registrations and trademark applications identified on Schedule 1 attached hereto (the “Pledged Trademarks”);

WHEREAS, the Security Interest was recorded with the United States Patent and Trademark Office – Trademark Division on December 2, 2011, at Reel 4671, Frame 0655; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Pledged Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby agrees and acknowledges as follows:

1. Definitions. Unless otherwise defined herein, terms used in this Agreement have the meanings provided in the Security Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Pledged Trademarks, including trademark registrations and trademark applications identified on Schedule 1 attached hereto and made a part hereof, and assigns to the Company, without recourse, all of the Agent’s right, title and interest in the Pledged Trademarks, and any right, title or interest of the Agent in such Pledged Trademarks shall hereby cease and be void. Agent understands and agrees that this Agreement may be recorded by or for the Company, as applicable, with the United States Patent and Trademark Office or any similar office or agency.
3. Further Assurances. Upon request by the Company, the Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest contemplated hereby.
