**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY RIGHTS**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS (this "Release"), dated as of November 1, 2018, is made by Royal Bank of Canada, as administrative agent (in such capacity, "Administrative Agent"), in favor of FBM Alpha LLC, Foundation Building Materials Holding Company LLC, Foundation Building Materials, LLC and FBM Logistics, LLC (collectively, the "Grantors"), as follows:

WITNESSETH:

WHEREAS, reference is made to the Term Loan Credit Agreement, dated as of August 13, 2018 (as amended, restated, supplemented or otherwise modified to date, the "Credit Agreement"), by and among FBM Alpha LLC, a Delaware limited liability company (formerly known as LSF9 Cypress Parent, LLC) ("Holdings"), Foundation Building Materials Holding Company LLC, a Delaware limited liability company (formerly known as FBM Beta LLC and LSF9 Cypress Holdings, LLC) (the "Borrower"), the several banks and other financial institutions or entities from time to time party thereto as lenders, and the Administrative Agent;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, a lien on and security interest in (the "Security Interest") certain collateral, including the IP Collateral (as hereinafter defined), was granted by Grantors to the Administrative Agent; and for the purpose of recording such Security Interest with respect to the IP Collateral with the United States Patent and Trademark Office, the Grantors entered into that certain Term Loan Intellectual Property Security Agreement dated as of August 13, 2018, (the "IP Security Agreement"), in favor of the Administrative Agent;

WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 13, 2018 at Reel 6412, Frame 0095 and with the Patent Division of the United States Patent and Trademark Office on August 13, 2018 at Reel 046886, Frame 0409; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the IP Collateral listed on Schedules 1-4 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "IP Collateral," as used herein, shall mean all of the Grantor's right, title and interest in, to and under the Copyrights, Trademarks, and Patents listed on Schedules 1-4 hereto. Capitalized terms not defined herein have the meanings set forth in the Credit Agreement and IP Security Agreement, as applicable.

2. Release of Security Interest. Administrative Agent, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby terminates, cancels, releases, relinquishes and forever discharges, in its entirety, for the benefit of Grantors, and their successors and assigns to the IP Collateral, its lien on and any and all security interest in and to

the IP Collateral, and retransfers, re-conveys and reassigns to each Grantor any and all right, title and interest of the Administrative Agent in, to and under the IP Collateral, and such right, title and interest of the Administrative Agent shall hereby terminate, cease and become void.

3. Recordation. Grantors authorize and request that the Commissioner for Trademarks and Commissioner for Patents record this Release.

4. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release.

5. Further Assurances. From time to time after the date hereof, upon Grantors' reasonable request, or upon the reasonable request of Grantors' successors, assigns or other legal representatives, Administrative Agent agrees to provide Grantors or their successors, assigns or other legal representatives with any information and additional authorization and documentation necessary to more fully and effectively effect the release of Administrative Agent's security interest in the IP Collateral (without recourse, representation or warranty and at Grantors' sole cost and expense).

6. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
