TRADEMARK ASSIGNMENT

This TRADE MARK ASSIGNMENT AGREEMENT (this "*Assignment*") is made and entered into as of August 22, 2018 ("*Effective Date*") by and between Mark L. Anderson of 303 South McKay Avenue, P.O. Box 39, Spring Valley, Wisconsin 54767 together with Jason Krause of 1120 E. 30 S. Pleasant Grove, Utah 84602 ("*Assignors*"), and Krause Dairy Products, LLC, a limited liability company ("*Assignee*") (each of Assignor and Assignee a "*Party*", and collectively, the "*Parties*").

WHEREAS, Assignors wish to assign to Assignee, and Assignee wishes to acquire from Assignor, any and all right, title and interest that Assignors own in the trademark, WRAPID CUT, Application No. 87/939,576, including all common law rights associated therewith and all goodwill of the business associated therewith and symbolized thereby (, the "*Trade Mark*");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby irrevocably and unconditionally assigns to Assignee, all of Assignor's right, title, and interest in and to the Trade Mark, together with the goodwill of the business symbolized by the Trade Mark, as successor of the business to which the Trade Marks relate. Assignor further irrevocably and unconditionally assigns to Assignee the right to bring all claims for past, present, and future infringement, misappropriation, or other violation of the Trade Mark, including all rights to sue for and to receive and recover all profits and damages accruing from an infringement, misappropriation, or other violation as well as the right to grant releases for past infringements.
2. Assignor hereby requests the United States Patent and Trademark Office (USPTO), and any corresponding entities or agencies in any applicable jurisdictions, to record Assignee as the assignee and owner of the Trade Mark.
3. This Assignment Agreement shall be construed and interpreted in accordance with the laws of the State of Utah without giving effect to any principles of conflict of laws.


