TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of November 02, 2018 by SILICON VALLEY BANK, as Administrative Agent (the “*Agent*”), in favor of Mi9 Retail ULC, a Canadian unlimited liability corporation (“*Mi9*”), Raymark ULC, a Canadian unlimited liability corporation (“*Raymark*”), and Just Enough Software Corporation, Inc., a Delaware corporation (“*Just Enough*”, together with Mi9 and Raymark, each individually and collectively, jointly and severally, the “*Grantor*”).

WHEREAS, Mi9 executed and delivered a Trademark Security Agreement, dated as of June 30, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Mi9 Agreement*”), granting the Agent a security interest in and lien on certain trademarks and trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on June 30, 2017, at Reel 6096, Frame 0437;

WHEREAS, Raymark executed and delivered a Trademark Security Agreement, dated as of June 30, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Raymark Agreement*”), granting the Agent a security interest in and lien on certain Trademarks described therein, which was recorded with the USPTO on June 30, 2017, at Reel 6096, Frame 0444;

WHEREAS, Just Enough executed and delivered a Trademark Security Agreement, dated as of February 8, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Just Enough Agreement*”, together with the Mi9 Agreement and the Raymark Agreement, each individually and collectively, jointly and severally, the “*Trademark Agreement*”), granting the Agent a security interest in and lien on certain trademarks described therein, which was recorded with the USPTO on February 8, 2018, at Reel 6269, Frame 0152;

WHEREAS, Grantor has requested that Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks (as defined in each respective Trademark Agreement) (collectively, the “*Trademark Collateral*”) as herein provided; and

WHEREAS, Grantor has requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grants and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
