**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF JOURNAL PUBLICATIONS, INC.**

In compliance with the requirements of the applicable provisions of 15 Pa. C.S. (relating to corporations and unincorporated associations) the Articles of Incorporation of Journal Publications, Inc. (the "Corporation") are hereby amended and restated to read as follows:

1. **NAME** The name of the Corporation is: Journal Multimedia Corporation
2. **REGISTERED OFFICE** The address of the Corporation's registered office in the Commonwealth of Pennsylvania is 1500 Paxton Street, Harrisburg, Dauphin County, PA 17104
3. **PURPOSE** The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Business Corporation Law of the Commonwealth of Pennsylvania.
4. **EXISTENCE** The Corporation is to have perpetual existence.
5. **STOCK** The aggregate number of shares which the Corporation is authorized to issue is 800,000 shares of common stock, par value \$0.001 per share (the "Common Stock").
