**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, Agent wishes to terminate, cancel, release, relinquish and discharge its security interest, and retransfer and reassign to the Grantors, without representation or warranty, all right, title and interest in and to the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates, cancels, releases, relinquishes and discharges its security interest, and retransfers and reassigns to the Grantors, without representation or warranty, all right, title and interest in and to the Trademark Collateral and any goodwill associated therewith.

Agent hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as Grantors may reasonably request to effect the release of Agent's security interest as contemplated hereby, in each case at Grantors' expense.
