TERMINATION AND RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of November 5, 2018, and made by **KEYBANK NATIONAL ASSOCIATION** (the "Agent"), to **ELIASSEN GROUP, LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Amended and Restated Trademark Security Agreement dated as of September 21, 2017 made by Grantor in favor of Agent (the "Security Agreement"), a security interest was granted by the Grantor to Agent in certain Trademark Collateral (as defined in the Security Agreement), including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on September 21, 2017 at Reel/Frame 6159/0080; and

WHEREAS, Agent now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in all of its trademarks, including those listed on Schedule A hereto.

2. Release of Security Interest. Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral, including, without limitation, the Trademarks, and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in the Trademark Collateral.


