3. Successors and Assigns. This Assignment will be fully binding upon, inure to the benefit of and be enforceable by the parties and their respective successors and assigns.
4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois, without regard to principles of conflicts of law.
5. Counterparts. This Assignment may be executed by facsimile signature (including by email or a pdf file) and in two or more counterparts, each of which shall be deemed to be an original but all of which together will constitute one and the same instrument.

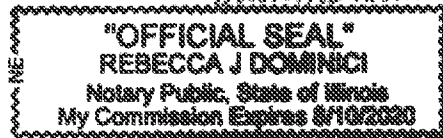
