**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of November 5, 2018, by **ACCESS CAPITAL, INC.** (the “Administrative Agent”).

**WITNESSETH:**

WHEREAS, the Administrative Agent entered into that certain Intellectual Property Security Agreement, dated as of December 21, 2011, with Dale and Thomas Popcorn, LLC, Popcorn, Indiana LLC, PICO Franchising, LLC, Dale and Thomas Growers, LLC, Popcorn, Indiana-OS, LLC and DTG Holdco, Inc. (each, a “Grantor” and, collectively, the “Grantors”) (the “Security Agreement”) in favor of the Administrative Agent, notice of which was recorded on December 28, 2011 at the United States Patent and Trademark Office at Reel 4687, Frame 0748;

WHEREAS, the Grantors granted the Administrative Agent, under the terms of the Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of such Grantors’ right, title, and interest in, to and under the trademarks listed on the attached **Schedule A** (the “Trademark Collateral”); and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Security Interest.
