TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is effective as of July 31, 2018 (the "Effective Date") by and between Gowan Milling, L.L.C., an Arizona limited liability company with its registered office at 370 S. Main Street, Yuma, Arizona 85364 ("ASSIGNOR") and Castle Dome Solutions, LLC, a limited liability company organized under Arkansas law, with its address at 1219 W. Martin Luther King Dr., Helena, AR 72342 ("ASSIGNEE").

BACKGROUND

WHEREAS, ASSIGNOR and ASSIGNEE entered into a Purchase and Transfer Agreement dated as of July 31, 2018 (the "Purchase Agreement"), pursuant to which ASSIGNOR is selling, assigning, transferring and conveying certain assets to ASSIGNEE; and

WHEREAS, although trademarks are not specifically mentioned in the Purchase Agreement, ASSIGNOR desires to transfer all of ASSIGNOR's right, title and interest in the trademarks listed on the attached Schedule A (herein defined as "TRADEMARKS"), and ASSIGNEE desires purchase such TRADEMARKS.

TERMS

NOW, THEREFORE, in consideration of the above premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intent to be legally bound, the parties hereto hereby agree as follows:

Effective as of the Effective Date, and subject to the terms and conditions of the Purchase Agreement, ASSIGNOR hereby sells, assigns, transfers and conveys to ASSIGNEE all right, title and interest in and to all TRADEMARKS, together with the goodwill of the business which they represent symbolized by the TRADEMARKS, including all associated trademark rights, service marks, service names, service mark rights, trade dress, slogans, logotypes and designs, and other indicia of origin, held by ASSIGNOR, together with all registrations and applications for registration of the TRADEMARKS, all claims, demands and rights to recovery that ASSIGNOR has or may have for past and future infringements, dilution or other violations of such TRADEMARKS, if any, and all rights to compromise, sue for, and collect on such claims, demands and rights to recovery.

ASSIGNOR and ASSIGNEE shall each take, any and all additional actions as may be reasonably necessary or appropriate to effect the assignment transactions contemplated herein. The responsibility to file assignments shall be on the ASSIGNEE and the ASSIGNEE shall bear the cost of filing such assignments.

ASSIGNOR hereby requests the United States Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any country foreign to the United States, to record this Assignment, as to the assigned TRADEMARKS herein referred to.

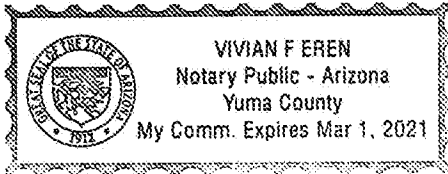

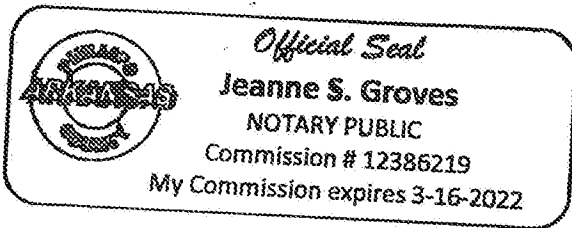
