RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), dated as of November 2, 2018, is made by **Newstone Capital Partners, LLC**, as Collateral Agent (“**Agent**”), having an office at Reagan Place at Old Parkland, 3963 Maple Avenue, Suite 100, Dallas, Texas 75219.

WHEREAS, **Revenue Advantage, Inc.** (“**Grantor**”) and Agent, are parties to that certain Second Lien Trademark Security Agreement (the “**Agreement**”) dated November 30, 2016 and recorded with the US Patent and Trademark Office on December 2, 2016 on Reel 5934, Frame 0265; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Agent a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including, without limitation, all of Grantor’s right, title and interest in and a continuing lien on the Trademark Collateral listed on Schedule I of the Agreement (attached hereto and made a part hereof as **Schedule I**); and

WHEREAS, Agent now desires to release its security interests granted in the Agreement in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and the Secured Parties, and their respective successors and assigns, hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) the Agreement and any and all other rights it may have under the same, and hereby reassigns to the Grantor any and all such right, title and interest (if any) that the Agent may have in, to and under the Trademark Collateral.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed in accordance with, the laws of the state of New York, without giving effect to any of its choice or conflict of laws provisions.
