TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Termination and Release") dated as of October 1, 2018, is made by JPMorgan Chase Bank, N.A., as administrative agent (together with any successors and permitted assigns thereto, in such capacity, the "Administrative Agent") for the Lenders, in favor of The Pullman Company (the "Grantor"). All capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Grant (as defined below).

WHEREAS, Grantor and the Administrative Agent entered into that certain Grant of Security Interest in Trademark Rights, dated as of May 12, 2017 (the "Trademark Security Grant"), granting Administrative Agent security interests in and liens on certain trademarks described therein (the "Trademark Collateral");

WHEREAS, the Trademark Security Grant was recorded with the United States Patent and Trademark Office ("USPTO") on June 5, 2017, at Reel/Frame 6077/0221;

WHEREAS, the Grantor has requested that the Administrative Agent enter into this Termination and Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Administrative Agent and the other Lenders may have in the Trademark Collateral pursuant to the Trademark Security Grant; and

WHEREAS, the Administrative Agent desires to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees:

1. Release of Security Interest. Administrative Agent hereby releases, terminates and discharges all liens and security interests the Administrative Agent has in, to and under the Trademark Collateral under the Trademark Security Grant, including the Patent Collateral identified in Schedule A hereto.
2. Filing the Release. Administrative Agent authorizes and requests that this Termination and Release be filed and recorded at the USPTO at Grantor's sole cost and expense.
3. Counterparts; Electronic Transmission. This Termination and Release may be executed and delivered by facsimile or other means of electronic transmission and such transmission shall constitute an original for all purposes.
4. Governing Law. This Termination and Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Termination and Release and the transactions contemplated hereby shall be construed in accordance with and governed by the law of the state of New York, without reference to its conflict of laws principles.
