TRADEMARK ASSIGNMENT (*Nunc Pro Tunc*)

WHEREAS by virtue of an assignment recorded with the U.S. Patent and Trademark Office ("USPTO") at Reel/Frame 3888/0942, EVRIHOLDER PRODUCTS, INC. ("Assignor"), a corporation formed under the laws of the State of California, having a correspondence address of 1530 South Lewis Street, Anaheim, California 92805 assigned U.S. Trademark Registration 2,740,231 (the "Registration") for FUREMOVER (the "Mark") to EVRIHOLDER PRODUCTS, LLC ("Assignee"), a limited liability company formed under the laws of the State of Indiana, having a correspondence address of 1530 South Lewis Street, Anaheim, California 92805;

WHEREAS, Paragraph 3 of the Assignment at Reel/Frame 3888/0942 appointed Assignee as Assignor's attorney in fact, with power to execute and deliver assignments and instruments in furtherance of the assignment from Assignor to Assignee;

WHEREAS, Assignee executed an Intellectual Property Security Agreement with HARRIS BANK, NA ("Harris") and CENTERFIELD CAPITAL PARTNERS II, L.P. ("CCP"), whereby Assignee granted a Security Interest in and to the Registration to Harris and CCP, which was duly recorded with the USPTO at Reel/Frame 3868/0078;

WHEREAS, it was the intention of the parties that Evriholder Products, Inc. (a California corporation) first assigned the Registration to Evriholder Products, LLC (an Indiana limited liability company); and Evriholder Products, LLC then executed an Intellectual Property Security Agreement to Harris and CCP; and

WHEREAS, because the assignment from Assignee to Harris and CCP was inadvertently recorded before the assignment from Assignor to Assignee, Assignor makes this Corrective Assignment, nunc pro tunc.

NOW, THEREFORE, for one dollar and good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor agrees that Assignor did assign, and hereby does assign, ***nunc pro tunc, effective as of August 13, 2008***, and does hereby sell, assign, transfer and convey to Assignee, and Assignee does hereby accept from Assignor, all of Assignor's right, title and interest in and to the Mark and the portion of the Assignor's business to which the Mark pertains, and the Registration and goodwill represented by the Mark, together with the right to bring and prosecute any claims or causes of action, and to seek all other relief in respect of any acts of infringement of the rights assigned hereinabove, irrespective of whether such acts have been committed before or were/are committed after the date of this Assignment, and the sole obligation to defend the Mark and the Registration.
2. Assignee takes the foregoing subject to the Intellectual Property Security Agreement with Harris and CCP. Assignee acknowledges that Assignor has no continuing responsibility to maintain the Mark and the Registration on a going forward basis, and agrees to defend and hold Assignor harmless against any third-party claims in connection with the same. Assignee agrees that it shall solely bear all liability for the costs of defense against claims by, and obligations to, third parties in connection with the Registration or the Mark.

3. Assignor authorizes and requests the USPTO (i) to transfer the Registration to Assignee, or otherwise as Assignee may direct, (ii) to cause the change of ownership be duly recorded in the official records of the USPTO and (iii) to deliver to Assignee, its attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.

4. Assignor warrants that, as of August 15, 2018, with the exception of the Intellectual Property Security Agreement with Harris and CCP (as recorded with the USPTO at Reel/Frame 3868/0078) that it had not conveyed to any other party any right, title, or interest in the Registration and/or Mark in Schedule A, or any license to use the same; and that, subject to the Intellectual Property Security Agreement with Harris CCP, Assignor had good right to assign the same to Assignee.

5. Assignor binds its successors, legal representatives, and assigns, as well as itself to do, upon Assignee's request and at Assignee's expense, but without additional consideration, all acts reasonably serving to assure that the said Mark and Registration shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor, its successors, legal representatives, and assigns if this assignment had not been made;
