**WORLDWIDE TRADEMARK ASSIGNMENT AGREEMENT**  
**(NUNC PRO TUNC)**

This Worldwide Assignment Agreement (“ASSIGNMENT”) is between Matthew Bordy, an individual residing at 329 Cipriani Way, North Venice, FL 34275 (“ASSIGNOR”), and Prototype House, Inc., a Florida corporation located at 719 E. Broward Blvd., Fort Lauderdale, FL 33301 (“ASSIGNEE”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR agrees that ASSIGNOR hereby assigned unto ASSIGNEE nunc pro tunc, effective as of February 9, 2013, and hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE any and all of ASSIGNOR’s rights, titles, interests of whatever kind in and to the Marks (including foreign and domestic rights), together with: (1) the goodwill of the business relating to the goods and services in respect upon which the Marks is used or will be used and which are identified above; (2) all income, royalty, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation damages and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks.

ASSIGNOR covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.

ASSIGNOR further covenants that it is the lawful owner of the Marks, that upon information and belief the same is unencumbered, free and clear of all liens, and not subject to

any claims of ownership, that there are no pending claims of infringement, and that ASSIGNOR has full right to make this ASSIGNMENT.
