Assignment of Notice of Grant of Security Interest in Trademarks

This Assignment of Notice of Grant of Security Interest in Trademarks, dated as of October 12, 2018, (this "Agreement"), is made by and between American Media, Inc. ("Assignor") and American, Media, LLC ("Assignee"). Defined terms in the Security Agreement (as defined below) have the same meanings where used herein, unless otherwise defined.

WHEREAS, Assignor entered into the Senior Secured Bridge Financing Agreement, dated as of June 29, 2018 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Financing Agreement"), by and among Assignor, each Person listed as a "Guarantor" on the signature pages thereto (together with each other Person that executes a joinder agreement and becomes a "Guarantor" thereunder or otherwise guaranties all or any part of the Obligations (as hereinafter defined), each a "Guarantor" and collectively, the "Guarantors"), the lenders from time to time party thereto (each a "Lender" and collectively, the "Lenders"), and Wilmington Trust, National Association ("Wilmington"), as collateral agent for the Lenders (in such capacity, the "Grantee"), and Wilmington, as administrative agent for the Lenders; and

WHEREAS, Assignor and the Grantors entered into a Pledge and Security Agreement, dated June 29, 2018 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of Grantee; and

WHEREAS, pursuant to the Security Agreement, Assignor and Grantee entered into a Notice of Grant of Security Interest in Trademarks, dated as of June 30, 2018 (together with all supplements and amendments thereto, the "Trademark Security Agreement"), pursuant to which, Assignor granted to the Grantee, for the benefit of the Secured Parties, a continuing security interest in all of Assignor's right, title and interest in and to the Trademarks, including the Trademark registrations and applications identified on Schedule A hereto (collectively, the "Trademarks"), which security interest was recorded in the United States Patent and Trademark Office on June 30, 2018 (Volume/Document number not yet available); and

WHEREAS, Assignor and Assignee entered into that certain Contribution and Assignment Agreement, dated as of October 12, 2018, by and between Assignor and Assignee (the "Contribution Agreement"), pursuant to which, Assignor contributed, transferred, granted, assigned and otherwise conveyed to Assignee all of the Assignor's right, title and interest in and to the Contributed Assets and Contributed Liabilities (as those terms are defined therein), including in and to the Trademarks; and

WHEREAS, Assignee and Grantee entered into that certain Joinder Agreement, dated as of October 12, 2018, by and among Assignee, Grantee and the other Parties thereto, pursuant to which, Assignee became a Grantor under the Financing Agreement and agreed to guarantee all or any part of the Obligations (as defined in the Financing Agreement); and

WHEREAS, in connection with the foregoing, Assignee wishes to assume all of Assignor's obligations under the Trademark Security Agreement; and

WHEREAS, Assignor and Assignee wish to record evidence of the assignment of Assignor's obligations under the Trademark Security Agreement to Assignee in the United States Trademark Office.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, each party hereto agrees as follows:

1. Assignment of Trademark Security Agreement. Pursuant to the terms set forth herein, Assignor hereby assigns to Assignee all of Assignor's obligations under the Trademark Security Agreement.


2. Purpose. This Agreement has been executed and delivered for the purpose of recording the assignment of security interest with the United States Trademark Office. The Trademark Security Agreement assigned hereby has been executed in connection with the Contribution Agreement. The parties hereto do hereby further acknowledge and affirm that the rights and remedies with respect to the security interest in the Trademarks are more fully set forth in the Financing Agreement and Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. The Financing Agreement and Security Agreement shall remain in full force and effect in accordance with their terms.

3. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
