## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT ("Termination and Release") dated as of November 9, 2018, is made by ByLine Bank, as agent for the Lenders under the Loan Agreement ("Agent") to Dedoes Industries LLC (f/k/a Dedoes Manufacturing LLC) ("Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement (defined below) or the Loan Agreement (defined below), as applicable.

### WITNESSETH:

WHEREAS, pursuant to that certain Revolving Credit and Term Loan Agreement dated as of October 5, 2016, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among the Grantor, Agent and the Lenders party thereto, the Grantor executed that certain Trademark Security Agreement, dated as of October 5, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), which was recorded in the United States Patent and Trademark Office at Reel 005900 Frame 0290, pursuant to which the Grantor granted a security interest to Lenders, in Grantor's Trademarks, including certain trademarks and/or trademarks applications listed on Schedule A attached hereto and made a part hereof.

WHEREAS, Agent and Lenders now desire to terminate and release their security interest in the Trademarks and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the Trademarks, including those set forth on Schedule A.
2. If and to the extent that Agent has acquired any right, title or interest in or to any of the Trademarks, Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by Agent, any and all of Agent's right, title, and interest in and to the Trademarks.
