**RELEASE OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (the "Release") is effective this 31 day of October, 2018, by and between Pancon Corporation, Pancon LLC, Paktron LLC, Pancon Illinois LLC, and Pancon Acquisition Corporation (collectively, "Grantors") and Marquette Business Credit, LLC ("Marquette").

WHEREAS, the Grantors entered into an Intellectual Property Security Agreement dated June 20, 2016 (the "IP Security Agreement") with Marquette;

WHEREAS, pursuant to the IP Security Agreement, the Grantors granted Marquette a security interest in all its right, title, and interest to the trademarks, including the trademarks listed at **Attachment A** (the "Marks"), among other collateral;

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on June 20, 2016 at Reel 5818, Frame 0076; and

WHEREAS, Marquette desires to release its security interest in and to the Marks pledged pursuant to the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Marquette agrees as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the IP Security Agreement.

Section 2. Release of Security Interest. Marquette hereby releases, relinquishes and discharges its security interest in and to the Marks and reassigns any and all interests it may have in such Marks to the Grantors.

Section 3. Further Assurances. Unless otherwise agreed by the parties, Grantors will record this Release with the USPTO. The parties agree to execute and deliver any and all further documents and instruments, and do any and all further acts which the other party (or its agents or designees) reasonably request in order to confirm this Release and Grantors' right, title and interest in, to and under the Marks.

Section 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the state of Delaware, but giving effect to federal laws applicable to national banks.
