AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

Tangoe, Inc. (the "**Corporation**"), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. This Certificate of Amendment (the "**Certificate of Amendment**") amends the provisions of the Corporation's Amended and Restated Certificate of Incorporation filed with the Secretary of State on June 16, 2017 (the "**Restated Certificate of Incorporation**").

2. Article FIRST of the Restated Certificate of Incorporation is hereby amended and restated in its entirety as follows:

"FIRST: The name of the Corporation is TANGOE US, INC."
