PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This Partial Release of Trademark Security Interest (this "Partial Release") is made effective as of November 13, 2018 by JPMorgan Chase Bank, N.A., as Administrative Agent (the "Administrative Agent") for the Secured Parties, to RIGZONE.COM, INC., a Texas corporation (the "Debtor"), as follows:

WHEREAS, on October 28, 2013, Debtor, the other Obligors and the Administrative Agent entered into a Security and Pledge Agreement (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and on each of October 28, 2013 and November 24, 2015 the Debtor and the Administrative Agent entered into a Notice of Grant of Security Interest in United States Trademarks (each a "Confirmatory Grant" and collectively, the "Confirmatory Grants");

WHEREAS, pursuant to the Security Agreement, Debtor granted to the Administrative Agent, on behalf of the Secured Parties, among other collateral, a continuing security interest in all of the Debtor's right, title and interest, including goodwill, in, to and under its trademarks, including but not limited to those listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Confirmatory Grants were recorded in the United States Patent & Trademark Office (the "USPTO") on October 30, 2013, at reel/frame 5141/0892; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Trademarks listed on Schedule A **only** and retransfer and reassign to the Debtor without recourse any of the Administrative Agent's right, title and interest in and to the Trademarks listed on Schedule A.

NOW, THEREFORE, the Administrative Agent hereby releases, terminates and discharges any security interest it may have under the Security Agreement or any Confirmatory Grant in the Trademarks listed on Schedule A **only**, and reassigns any and all right, title and interest it may have in and to the Trademarks listed on Schedule A without recourse to the Debtor, and such security interest shall hereby terminate, cease and become void; and the Administrative Agent hereby consents to the recording of this Partial Release with the USPTO.
