**TERMINATION AND RELEASE
OF GRANT OF SECURITY INTEREST (TRADEMARK)**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARK) (this "Release"), dated as of November 14, 2018, by WEBSTER BANK, NATIONAL ASSOCIATION (the "Administrative Agent"), in favor of TRANZLATIONS, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to the terms of that certain Grant of Security Interest (Trademark), dated as of May 26, 2017 (the "Trademark Security Agreement"), by the Grantor in favor of the Administrative Agent, the Grantor granted to the Administrative Agent a security interest in and to the following property of the Grantor, now owned or hereafter acquired by the Grantor (collectively, the "Collateral"):

- (a) trademarks and registrations thereof, including the trademark listed on Schedule 1 (collectively, the "Trademark");
- (b) the goodwill of the business symbolized by the Trademark; and
- (c) all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof.

WHEREAS, the Administrative Agent wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral; and

WHEREAS, the Trademark Security Agreement was filed on May 30, 2017 with the United States Patent and Trademark Office in Reel: 6072; Frame: 0408.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Trademark Security Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Administrative Agent may have in the Collateral, and terminates the Trademark Security Agreement. The Administrative Agent hereby authorizes the Grantor, or the Grantor's authorized representative or designee, to record this Release with the United States Patent and Trademark Office.
