## NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Notice"), dated as of November 14, 2018, is filed by Candy Club, LLC, a California limited liability company ("Borrower"), to provide notice of the release of a security interest held by Venture Lending & Leasing VII, Inc. and Venture Lending & Leasing VIII, Inc. 5. Borrower and Lender hereby request the PTO to file and record the same together with the annexed Schedule 1.

6. Borrower and Lender hereby acknowledge and agree that the security interest in the Trademark Collateral has been terminated.






