**FIRST LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This First Lien Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of October 11, 2018, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (the “Collateral Agent”) in favor of **TECH LOCK, INC.**, an Illinois corporation with an address at 223 N. Milwaukee Ave., Suite 12, Gurnee, Illinois 60031 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated November 30, 2016 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on December 1, 2016 at the United States Patent and Trademark Office at Reel 5931, Frame 0705.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its Trademark Collateral, including the Trademark Collateral listed in **Schedule A**, all Proceeds and products of the Trademark Collateral, the goodwill of the businesses with which the Trademark Collateral is associated, and all causes of action arising prior to or after the date hereof for infringement of any of the Trademark Collateral or unfair competition regarding the same.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including the goodwill of the businesses with which the Trademark Collateral is associated, and assigns, transfers and conveys to Grantor any interest in such intellectual property.


