REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is executed as of November 15, 2018 by SILICON VALLEY BANK, a California corporation (the “Assignor”) for the benefit of HYPERWALLET SYSTEMS INC., a corporation incorporated under the laws of Canada (the “Assignee”), with its principal executive office located at 11401 Century Oaks Terrace, Suite 400, Austin, TX 78758.

RECITALS

A. WHEREAS, Assignee assigned certain interests in the Intellectual Property Collateral (as defined below) to Assignor pursuant to a certain Intellectual Property Security Agreement dated as of May 19 2016 and recorded in the United States Patent and Trademark Office on (1) January 6, 2017, at Reel 040871 and Frame 0030 for patents and at Reel 5960 and Frame 0453 for trademarks, (2) February 6, 2018, at Reel 044841 and Frame 0916 for patents, and (3) February 28, 2018, at Reel 045069 and Frame 0396 for patents; and

B. WHEREAS, the Assignor wishes to release and reassign all interest that such Assignor may have in the Intellectual Property Collateral.

AGREEMENT

1. Release of Security Interest. Assignor hereby releases its security interest in all of Assignee’s right, title and interest in, to and under its intellectual property (all of which shall collectively be called the “Intellectual Property Collateral”) including, without limitation, the following:

a) Any and all copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit A attached hereto (collectively, the “Copyrights”);

b) Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;

c) Any and all design rights that may be available to Assignee now or hereafter existing, created, acquired or held;

d) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the “Patents”);

e) Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Assignor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the “Trademarks”);

f) All mask works or similar rights available for the protection of semiconductor chips, now owned or hereafter acquired, including, without limitation those set forth on Exhibit D attached hereto (collectively, the "Mask Works");

g) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

h) All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;

i) All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

j) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.


