**RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN) (this “Release”), dated as of November 16, 2018 (the “Effective Date”), is made by ROYAL BANK OF CANADA, in its capacity as Collateral Agent (the “Agent”), in favor of INTRALINKS, INC. (the “Grantor”).

WHEREAS, pursuant to that certain Second Lien Guarantee and Collateral Agreement, dated as of November 14, 2017, by the Grantor and certain other parties thereto in favor of the Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent a security interest in and to certain collateral, including the Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Second Lien Grant of Security Interest in Trademarks, dated as of November 14, 2017 (the “Trademark Security Agreement”), the Grantor granted to the Agent a security interest in and to the Trademark Collateral, for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 16, 2017 at Reel/Frame 6206/0895; and

WHEREAS, the Agent has agreed to execute and deliver this Release for recordation with the United States Patent and Trademark Office.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined, herein shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement.
2. Release. The Agent (on behalf of the Secured Parties), without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and Lien on all of the right, title and interest of the Grantor in all of the Trademarks included in the Collateral, including the trademark and service mark registrations and applications set forth Schedule I attached hereto (collectively, the “Trademark Collateral”), arising under the Security Agreement and the Trademark Security Agreement. If and to the extent that the Agent or any Secured Party has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement or the Trademark Security Agreement, the Agent (on behalf of the Secured Parties), without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns all such right, title or interest to the Grantor.
3. Termination. The Agent, without representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
