TRADEMARK SECURITY AGREEMENT RELEASE

This **TRADEMARK SECURITY AGREEMENT RELEASE** (this "Release") is granted as of the date signed below (and retroactive to the date that the appurtenant obligations were satisfied or extinguished) by State Street Bank and Trust Company, a Corporate Trust Company, located at 61 Broadway, 15th Floor, New York, New York 10006 USA in its capacity as Collateral Agent ("Secured Party"), in favor of Perry Ellis International, Inc., a Delaware Corporation, located at 3000 NW 107th Avenue, Miami, Florida 33172 USA (the "Released Party").

WITNESSETH:

WHEREAS, the Secured Party is a party to a Trademark Security Agreement executed on March 22, 2002 (as amended, supplemented, extended, restated, or otherwise modified prior to the date hereof, the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on April 8, 2002, at Reel 2486, Frame 0001, against certain trademarks identified on Schedule A hereto;

WHEREAS, the Secured Party has agreed to execute this Agreement so that the Released Party may record it with the USPTO and demonstrate that all liens against the trademarks identified on Schedule A have been extinguished or satisfied.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. Release of Security Interest. The Secured Party hereby terminates, releases, and discharges in favor of the Released Party any and all security interests and liens upon the trademarks identified on Schedule A hereto, together with all products and proceeds thereof. Accordingly, to the extent that the Trademark Security Agreement and any related liens remained valid, those liens are hereby terminated and are of no further force and effect.

2. Reassignment. The Secured Party hereby reassigns, grants, and conveys to the Released Party, without any representation, recourse or undertaking by the Secured Party, all of the Secured Party's right, title, and interest in and to the trademarks identified in Schedule A to the extent that the Released Party owns valid rights in those marks and they have not been abandoned or otherwise transferred to other entities.


3. Governing Law. THIS RELEASE AND ANY DISPUTE, CONTROVERSY, PROCEEDING, OR CLAIM SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF FLORIDA, WITHOUT REFERENCE TO OR INCLUSION OF THE PRINCIPLES OF CHOICE OF LAW OR CONFLICTS OF LAW OF THAT JURISDICTION.

4. Successors and Assigns. This Release shall be binding upon and inure to the benefit of the parties, all future holders of the trademarks listed in Schedule A, and the respective successors and assigns.

5. Counterparts. This Release may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one instrument.
