**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, Digital Pharmacist Inc., a Delaware corporation with its principal place of business at 4315 Guadalupe Street, Suite 200, Austin, Texas 78751 ("*Digital Pharmacist*"), is the owner of record of the United States Trademark Registration No. 4,299,464 for RXWIKI (the "*Trademark*"); and

WHEREAS, Digital Pharmacist was formerly known as RxWiki Inc. ("*RxWiki*"), and a notice of such name change with respect to the Trademark was recorded by the United States Patent and Trademark Office (the "*USPTO*") on September 14, 2017, at Reel 6154, Frame 0933;

WHEREAS, Patient Conversation Media, Inc. ("*Patient Conversation*") assigned all of Patient Conversation's rights in the Trademark to RxWiki, and a copy of such assignment was recorded by the USPTO on November 1, 2016, at Reel 5912, Frame 0610;

WHEREAS, Patient Conversation entered into that certain Intellectual Property Security Agreement dated as of March 11, 2013 (the "*Security Agreement*"), between Patient Conversation and Silicon Valley Bank ("*Secured Party*"), copy of which was recorded by the USPTO on April 2, 2013, at Reel 4996, Frame 0792;

WHEREAS, the Secured Party desires to release its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Secured Party hereby releases and reassigns to Digital Pharmacist any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the Trademark.
