**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARK**

This RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARK, effective as of October 1, 2018 (this "Release"), is executed and delivered by EAST WEST BANK (the "Agent"), in favor of ACCESS POINT, INC., a North Carolina corporation (the "Grantor").


WHEREAS, the Grantor and the Agent entered into that certain Grant of Security Interest in United States Trademark, dated as of June 2, 2016 (the "Grant"), whereby the Grantor granted the Agent security interests in (a) all of Grantor's right, title and interest in and to the United States trademark number 2965180 registered on July 5, 2005 (the "Mark"), (b) all proceeds and products of the Mark, (c) the goodwill of the businesses with which the Mark is associated and (d) all causes of action arising prior to or after the date of the Grant for infringement of the Mark or unfair competition regarding the same (collectively, the "Collateral"); and

WHEREAS, the Grant was recorded with the United States Patent and Trademark Office on June 9, 2016 at Reel/Frame 5810/0221.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent releases its entire right, title, and interest in the Collateral, including all rights the Agent may have to sue for damages and other remedies in respect of any infringement of the Collateral which may have occurred before the date of this Release.
