**Recital**



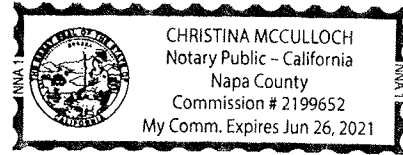
