Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Rural Press (USA) Limited, a Delaware corporation, and the names of the corporations being merged into this surviving corporation are Farm Progress Companies, Inc., an Illinois corporation, Farm Progress Holding Company, Inc., a Delaware corporation, Farm Progress Insurance Services, Inc., an Illinois corporation, Indiana Prairie Farmer Insurance Services, Inc., an Indiana corporation, Rural Press USA, Inc., a Georgia corporation and The Miller Publishing Company, Inc., a Minnesota corporation.

SECOND: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252.

THIRD: The name of the surviving corporation is Rural Press (USA) Limited, a Delaware corporation.

FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.


FIFTH: The merger is to become effective on October 31, 2017.
