TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made and entered into as of this 14th day of November 20 1988 ("Effective Date"), Task Lighting Corporation, a Nebraska corporation having a principal place of business at P. O. WHEREAS, Assignee desires to acquire the entire right, title and interest in and to the Marks, and any registrations therefor, together with the goodwill of the business in connection with which the Marks are used;

WHEREAS, Assignor desires to transfer all of its right, title, and interest in and to the Marks, and any registrations therefor, together with the goodwill of the business in connection with which the Marks are used;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby makes the transfer and assignment of all of Assignor's rights in and to the Marks as follows:


1. Assignor hereby irrevocably sells, assigns, transfers, conveys, and sets over unto Assignee any and all of Assignor's right, title, and interest, throughout the world, in and to the Marks, and any and all registered and unregistered trademarks, logos, designs, brands, and all other indications of origin related to Assignee's products and services, including, but not limited to, all trademarks, service marks, brand names, and trade dress, together with the goodwill of the business in connection with which the Marks and all other indications of origin are used and that part of the goodwill of the business connected with the use of and symbolized by the Marks or other indications of origin, including all registrations and applications therefor, if any, as well as all renewals and extensions of registrations that are or may be secured by Assignee, its successors, assigns or other legal representatives, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Agreement had not been made;
2. Assignor further covenants and agrees that it will, at any time upon request and at Assignee's sole cost and expense, execute and deliver any and all documents that may be reasonably necessary or desirable to perfect Assignee's rights in and to the Marks; and
3. This Agreement includes any and all rights to past, present, and future causes of action for infringement or other unauthorized use of the Marks including the right

to sue for damages and/or obtain injunctive relief for past, present, and future infringement, misappropriation or other unauthorized use of the Marks and recover any such damages for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee, and at Assignee's sole cost and expense, to enforce the rights transferred hereunder.
