**TRADEMARK ASSIGNMENT AGREEMENT**

WHEREAS, Assignee and Assignor are parties to an Agreement dated July 18, 2018 (the "*Agreement*"), pursuant to which Assignor is to assign to Assignee all of Assignor's right, title, and interest in, to and under the Assigned Trademark, and any registrations and pending applications therefor, including without limitation U.S. Trademark Registration No. 5,124,839;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment. Assignor hereby assigns, transfers, conveys, and delivers to Assignee and its successors and assigns, and Assignee hereby purchases and accepts from Assignor, all of Assignor's right, title, and interest in, to, and under the Assigned Trademark, including without limitation U.S. Trademark Registration No. 5,124,839, together with the right to sue and recover damages for future, present, and past infringements of the Assigned Trademark and to fully and entirely stand in the place of the Assignor in all matters related to the Assigned Trademark.

2. Further Assurances. Assignor agrees to execute and deliver such other documents and to take all other actions which Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment, and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens, and other documentation as may be reasonably required to effect the terms of this Assignment and its recordation in relevant state and national trademark offices.

3. Recordation. Assignor grants the attorney of record the power to insert on this Assignment any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this Assignment.



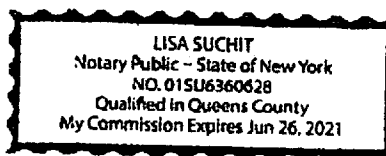


