RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of November 27, 2018 (the "Effective Date") by JPMorgan Chase Bank, N.A., as collateral agent for the Secured Parties (as defined below) ("Security Agent"), in favor of the Grantors party to the Trademark Security Agreement (as defined below) and of the Grantors party to the Copyright Security Agreement (each as defined below).

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of December 21, 2015 (the "Trademark Security Agreement"), each entity listed as a Grantor on the signature pages thereto (collectively, the "Trademark Grantors") granted to the Security Agent for the benefit of the Secured Parties under the Notes Pledge and Security Agreement dated as of December 21, 2015, among the Trademark Grantors, the other grantors party thereto and the Security Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement") a security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the terms and conditions of that certain Copyright Security Agreement dated as of December 21, 2015 (the "Copyright Security Agreement"), each entity listed as a Grantor on the signature pages thereto (collectively, the "Copyright Grantors") granted to the Security Agent for the benefit of the Secured Parties under the Pledge and Security Agreement a security interest in and to the Copyright Collateral (as defined in the Copyright Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 21, 2015, at Reel/Frame number 5693/0776, against the Trademarks on Schedule A to the Trademark Security Agreement, which is attached as Annex A hereto;

WHEREAS, the Copyright Security Agreement was recorded with the U.S. Copyright Office on December 22, 2015, at Volume 9931, Document No. 756, against the Copyrights on Schedule A to the Copyright Security Agreement, which is attached as Annex B hereto; and

WHEREAS, the Security Agent now desires to terminate the Trademark Security Agreement and the Copyright Security Agreement, and release its security interest in and to the Trademark Collateral and the Copyright Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Pledge and

Security Agreement, the Trademark Security Agreement or the Copyright Security Agreement, as applicable.

2. Release of Security Interest in Collateral.

The Security Agent hereby terminates, releases, and discharges its security interest in the Trademark Collateral and the Copyright Collateral, and reassigns to the Trademark Grantors and the Copyright Grantors, as the case may be, any and all right, title, and interest the Security Agent may have in, to or under the Trademark Collateral and the Copyright Collateral.

The Security Agent hereby acknowledges and agrees that Trademark Grantors and the Copyright Grantors have completely and timely satisfied their obligations in full, and hereby terminates each of the Trademark Security Agreement and the Copyright Security Agreement. The Security Agent hereby confirms the Trademark Grantors and the Copyright Grantors shall have no further obligations of any kind under the Trademark Security Agreement or the Copyright Security Agreement, as the case may be.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America or her delegate to record this Release against the Collateral. The Security Agent hereby represents and warrants that it has full power and authority to execute and deliver this Release.

3. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

4. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
