RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of November 15, 2018, by JPMORGAN CHASE BANK, N.A., a national banking association (the "Lender") regarding NATURAL BEAUTY GROWERS, LLC, a Wisconsin limited liability company (f/k/a Floral Plant Growers, L.L.C., a Wisconsin limited liability company, f/k/a Floral Plant Growers, L.L.C., a Delaware limited liability company) (the "Debtor"), with reference to the following facts:

WHEREAS, on August 29, 2014, the Debtor granted a continuing and unconditional security interest to the Lender in the following, whether then existing or thereafter arising or acquired: (i) Debtor's trademarks, including without limitation those set forth on Exhibit A, (ii) associated goodwill therein, and (iii) all proceeds and benefits thereof (collectively, the "Trademark Collateral"), for the purpose of securing certain obligations of the Debtor to the Lender (which security interest was recorded at the U.S. Patent and Trademark Office at Reel/Frame number 5355/0155); and

WHEREAS, the Lender desires to release any security interest it might have in the Trademark Collateral and reassign any and all rights, title and interests in the same to Debtor.

NOW, THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged: the Lender hereby (i) unconditionally terminates, releases and discharges any and all security interest, right, title or other interest it may have in the Trademark Collateral, and (ii) reassigns, grants and conveys to the Debtor, without any recourse, any and all of the Lender's right, title and interest in and to the Trademark Collateral, along with any goodwill in the trademarks therein that Lender may have acquired.
